The JDS Consulting team has extensive experience in DBE project planning and goal preparation for capital programs (please see attached DOTD DBE Certification). The ultimate goal of this contract is to increase contracting opportunities for qualified DBE firms in Ouachita Parish with an emphasis on those located within districts 3,4, and 5.

For this project, we have identified the following goal setting tasks:

- Conduct a Disadvantaged Business Enterprise (DBE) Disparity Study consistent with constitutional and legislative mandates, governing law, and best practices (the cost of which will be determined and included in a separate proposal)
- Conduct outreach to create and maintain a database of DBEs
- Collaborate with resource partners to conduct workshops to train DBEs for contract eligibility and obtain DBE/MBE/SBE/HubZone and Hudson Initiative certifications
- Devise and maintain a system to alert and apprise DBEs of bid opportunities
- Promote networking opportunities for DBEs in cooperation with all Chambers of Commerce
- Renovate the Arizona Street location as a DBE training center and shared office facility for Southside businesses.

Considering the aforementioned, we feel confident that we will be able to attain a goal of 30% DBE participation by year three.

Be advised that recent changes in the Federal Regulations which govern our **DBE** and **SBE** program have removed expiration dates on certifications. Therefore, recertification every three (3) years is no longer needed. However, you will be required to submit an <u>annual</u> affidavit, along with all supporting documents, stating that your firm continues to meet the eligibility requirements of the program.
